Job Summary:

Create a positive learning environment where children learn sportsmanship, fundamental skills, teamwork, responsibility, and other positive character traits.

SCGA Junior Golf Foundation's programs emphasize both player and youth development by providing a fun, safe and engaging community for players, parents, and coaches. The coach is responsible for supporting golf practices and creating a welcoming environment. This position will be based out of Don Knabe GC, Los Amigos GC, Pico Rivera GC and/or Whittier Narrows GC in Southeast Los Angeles.

Essential Duties and Responsibilities include:

Youth Coaching

- Serve as a positive role model to the players and parents
- Teach sportsmanship, work ethic, responsibility, and other positive character traits
- Manage equipment including practice set up and breakdown
- P Ensure practices are fun, engaging, and energized
- Follow a pre-set practice schedule of drills and exercises to teach fundamental skills
