#### DEAR COMPETITORS,





#### **AWARDS**

Awards will be presented immediately following the final round. In the event of a tie for first place only, a three-hole aggregate playoff will commence following the conclusion of regular play to determine the champion.



## **CHAMPIONSHIP INFORMATION**

#### STARTING TIMES AND PAIRINGS

- » Starting times and pairings will be emailed to players and posted online at <u>scga.org/amateu</u>r the week prior to the championship.
- » The lead group should plan to be at their assigned tee 10 minutes in advance of their starting time. Subsequent groups are encouraged to arrive once the preceding group has teed off. Players arriving late will be penalized under Rule 5.3a of the Rules of Golf. For example, the 9:00 a.m. starting time is defined as 9:00:00, and players arriving after that time are considered late.

#### PRACTICE ROUNDS

- » Once the championship field is finalized, players will be provided instructions as to how to secure a practice round reservation through the <u>Event Portal</u>. Players should not contact Rolling Hills CC to arrange a practice round.
- » Practice rounds are for players only. Players may bring a caddie, but the caddie may not play.

#### TEES AND HOLE YARDAGES

Click <u>here</u> to view the maximum hole-by-hole yardage ranges for the SCGA Amateur Championship.

#### PARKING AND REGISTRATION

- » Ample self-parking will be available at the club.
- » All participants must check in at the registration table located near the practice putting green upon arrival on Monday.

#### **DRIVING RANGE**

The driving range will open one hour prior to play each day of the championship.

#### LOCKER ROOM

Players will have access to the club's locker room, which will open one hour prior to play each day of the championship.

#### DRESS CODE

Appropriate golf attire must be worn, including adhering to any club-specific policies.

#### **FOOD SERVICE**

- » The snack bar will be available for purchases with major credit cards.
- » More details on food & beverage will be communicated closer to the championship.



#### **SPECTATORS**

- » Spectators are welcome and encouraged to attend the SCGA Amateur Championship.
- » Spectators will not be permitted in golf carts.
- » If spectators have any questions leading up to the event, please contact the SCGA Championships & Golf Operations Department at <u>champs@scga.org.</u>

#### MOBILE DEVICE POLICY

- » Players, caddies and spectators should turn mobile devices off or to silent mode while on the property and limit calls to the club's parking lot.
- » Live scoring will be available throughout the championship at <u>scga.org</u>.



#### AUTOMOTIVE TRANSPORTATION

- » During a round, a player must not ride on any form of motorized transportation except as authorized or later approved by the Committee (Model Local Rule G-6).
- » Players seeking to use a golf cart due to a medical or ADA-related reason must make arrangements with SCGA staff in advance of the championship.
- » Pull or push carts are permitted.





#### RULES OF PLAY

- » Prior to participating, participants must review the SCGA's Policies & Procedures.
- » The <u>Rules of Golf</u> as approved by the USGA and The R&A govern play.
- » Local Rules and Terms of the Competition can be found on the <u>SCGA Hard Card</u> and the Notice to Players that will be emailed to players the day prior to the qualifier.
- » Click here to review the SCGA Pace of Play Policy.

#### CODE OF CONDUCT

By submitting an entry for any SCGA-administered competition, the contestant understands that his/her participation is at the sole discretion of the SCGA. A contestant may be removed from any competition at the discretion of the SCGA staff or Championship Committee at any time before or during the competition. Incidents of unbecoming conduct or actions deemed to be detrimental to the image of the SCGA or the "Spirit of the Game" are grounds for such removal and suspension from future SCGA-administered competitions. These include, but are not limited to, the following:

- » Willful damage of the golf course or golf course property
- » Club throwing or unnecessary club tossing
- » Offensive or unbecoming language
- » Public criticism of golf course or verbal abuse of SCGA staff, officials, volunteers, host club staff or other contestants
- » Potential endangerment of others
- » Conduct deemed unbecoming
- » Failure to post scores for handicapping purposes
- » Manipulation of scores posted for handicapping purposes

#### CANCELLATION POLICY

» To withdraw for any reason prior to the start of the championship, a player must notify the SCGA Championships & Golf Operations Department at <a href="mailto:champs@scga.org">champs@scga.org</a>.

#### Refund Policy:

- » Cancelation prior to the entry closing date: Full refund less a \$20 administrative fee.
- » Cancelation after the entry closing date and more than 48 hours prior to the start of the competition: **50% of the entry fee.**
- » Cancelation within 48 hours of the start of the competition: No refund.

## **PACE OF PLAY POLICY**

#### **MAXIMUM ALLOWABLE TIME:**

The Committee at each competition will determine the maximum allowable time each group is permitted to play the round and each hole. This time will be posted on each player's scorecard, and each player and group is expected to maintain a pace that is faster than the maximum allowable time. A hole ends in stroke play when all players have holed out, and in match play, when all players hole out or the result of the hole is decided. See Rule 23.3c for when a hole is completed in four-ball competition.

#### IN POSITION:


Groups are expected to remain in position throughout the round. Being in position means:

- Reaching the teeing area of a par-3 before the group ahead has teed off on the next hole.
- Reaching the teeing area of a par-4 before the group ahead leaves the putting green of that hole.
- Reaching the teeing area of a par-5 before the group ahead gets to the putting green of that hole.

#### WARNING, CHECKPOINTS & PENALTIES:

If a group is over its maximum allowable time and out of position, an SCGA official may issue the group a warning and provide a checkpoint by when the group must regain its position (e.g., within the next two or three holes). If a group receives a warning, it will be monitored by an SCGA official to observe its pace of play.

- If a group fails to regain its position by an established checkpoint, all players in the group will be informed that the checkpoint was missed and that one or more players in the group will be liable to receive a one-stroke penalty. The SCGA official will then provide another checkpoint by when the group must regain its position.
- If the group fails to regain its position a second time, one or more players in the group will be liable to receive the general penalty (loss of hole in match play or two penalty strokes in stroke play).

## LOCAL RULES AND TERMS OF THE COMPETITION

The Rules of Golf as approved by the United States Golf Association and The R&A govern play. These Local Rules and Terms of the Competition are in effect at all SCGA championships and qualifying rounds. See applicable championship or qualifying round Notice to Players and Entry Application for modifications or additions to these Local Rules and Terms of the Competition. Complete text of the Rules and Local Rules may be found in the Official Guide to the Rules of Golf, effective January 2023.

Unless otherwise noted, the penalty for breach of a Local Rule is the general penalty.

#### LOCAL RULES

**OUT OF BOUNDS** — Defined by the line between the course-side points of white stakes and fence posts at ground level.

**PENALTY AREAS** — When a penalty area is defined on only one side, it extends to infinity. When a penalty area is connected to the out-of-bounds edge, the penalty area extends to and coincides with out of bounds.

**GROUND UNDER REPAIR** – Defined by white lines. French drains are ground under repair.

Ground under repair may include areas of unusual damage but only when so declared by an authorized member of the Committee. When immediately adjacent to an immovable obstruction, such an area is part of that obstruction.

**RELIEF FROM SEAMS OF CUT TURF (SOD SEAMS)** — Model Local Rule F-7 as prescribed in Section 8 of the Committee Procedures is in effect.

**AERATION HOLES** – Model Local Rule E-4 as prescribed in Section 8 of the Committee Procedures is in effect.

**EDGING GROOVES** – Model Local Rule F-19 as prescribed in Section 8 of the Committee Procedures is in effect.

WHITE-LINED AREAS TYING INTO ARTIFICIALLY SURFACED ROADS AND PATHS —White-lined areas of ground under repair and the artificially surfaced roads, paths or other identified obstructions that they are connected to are a single abnormal course condition when taking relief under Rule 16.1.

WOOD CHIPS AND MULCH - Are loose impediments.

**INTEGRAL OBJECTS** – Include artificial walls and pilings when located in penalty areas or in or adjacent to bunkers.

**PROHIBITING USE OF CERTAIN TYPES OF SHOES** – Model Local Rule G-7 as prescribed in Section 8 of the Committee Procedures is in effect.

**LIST OF CONFORMING DRIVER HEADS** – Model Local Rule G-1 as prescribed in Section 8 of the Committee Procedures is in effect.

**BROKEN OR SIGNIFICANTLY DAMAGED CLUB** – Model Local Rule G-9 as prescribed in Section 8 of Committee Procedures is in effect.

**MISSING PLAYER OR MARKER CERTIFICATION** – Model Local Rule L-1 as prescribed in Section 8 of the Committee Procedures is in effect.

**PRACTICE** — Prior to and after a round in stroke play, a player may practice on the designated practice areas. Rule 5.2b covering practice in stroke play is modified in this way: A player may not practice on the competition course before or between rounds. Penalty for breach of Local Rule, see Rule 5.2.

**PACE OF PLAY** – See separate memorandum to players for pace of play policy.

**STOPPING AND RESUMING PLAY** – Model Local Rule J-1 as prescribed in Section 8 of the Committee Procedures is in effect.

All practice areas are closed during an immediate suspension for a dangerous situation until the Committee has declared them open. Players who practice on closed practice areas will be asked to stop practicing; failure to stop practicing might result in disqualification.

An immediate suspension will be signaled by one prolonged air horn note. All other types of suspension will be signaled by three consecutive air horn notes. Resumption of play will be signaled by two short air horn notes.

#### WHEN COMPETITION IS FINAL:

**Stroke Play:** When the results and/or qualifiers and alternates have been determined. At championships, when the awards have been presented.

**Match Play:** When the result of a match has been reported to, and verified by, the committee.

**CODE OF CONDUCT\*** – By submitting an entry for any SCGA-administered event, the contestant understands that his/her participation is at the sole discretion of the SCGA. A contestant may be removed from an event either before or during the event at the sole discretion of the SCGA. Incidents of unbecoming conduct or actions deemed to be detrimental to the image of the SCGA or the "Spirit of the Game" are grounds for such removal and suspension from future SCGA-administered events.

These include, but are not limited to, the following:

- Willful damage of the golf course or golf course property
- Club throwing or unnecessary club tossing
- Offensive or unbecoming language
- Public criticism of golf course or verbal abuse of SCGA staff, officials, volunteers, host club staff or other contestants
- Potential endangerment of others
- Conduct deemed unbecoming
- Failure to post scores for handicapping purposes
- Manipulation of scores posted for handicapping purposes

#### PENALTY FOR BREACH OF CODE OF CONDUCT

First Offense: Warning
Second Offense: Disqualification

\*The Committee may disqualify a player for serious misconduct in failing to meet the Code's standards.

# HISTORY OF THE SCGA AMATEUR CHAMPIONSHIP

The SCGA Amateur is one of the nation's oldest continuously contested amateur golf championships. The first SCGA Amateur was held less than one year after the Southern California Golf Association

was formed on July 29, 1899. Only the Utah Amateur, started in 1899, has a longer consecutive string (the U.S. Open and U.S. Amateur both predate the SCGA Amateur, but both USGA events were suspended during war years).

A match play format was used for the first 58 years of the tournament. In 1957, the format was changed to 72 holes of stroke play. In 1973, increasing interest and the number of entries resulted in regional qualifying with a 36-hole finale. The 72-hole stroke play format was reinstituted in 1974. In addition to the championship itself, for many years the tournament also had net competition in flights. However, due to the increasing popularity of this portion of the tournament, a separate SCGA Amateur Net Championship was created in 1993.

The list of SCGA Amateur champions includes many of the legendary names of golf. Charles E. Orr, who won the first title with a 6 and 4 win over SCGA President Charles Maud, was described as a "crack player from the Pasadena Country Club."

Another Pasadena resident, Dr. Paul Hunter,

won a record five SCGA Amateur titles from 1912 to 1929. In 1925, George Von Elm became the only player ever to win the SCGA Amateur, NCGA Amateur and California Amateur in the same year (a year later, he became the first Southern Californian to win the U.S. Amateur).

In 1933, another legendary amateur, Charles Seaver (who was also the father of baseball Hall of Fame pitcher Tom Seaver), won the California Amateur and NCGA Amateur. When he won the SCGA Amateur in 1934, he held all three titles at the same time for a few weeks; only Von Elm has equaled that feat.

The '40s were a golden age of golf in Southern California, with the likes of Johnny Dawson, Bobby Gardner and Bruce McCormick — all eventual Walker Cuppers — capturing SCGA Amateur titles. Notable winners in the 1950s included future PGA Champion Al Geiberger (in 1956 and 1959) and car dealer Fletcher Jones, while future PGA Tour members


Barry Jaeckel, John Jacobs, Mark Pfeil, Tony Sills, Jeff Hart, Greg Twiggs, Dave Sheff, David Hobby, Paul Stankowski, Todd Demsey, Charlie Wi and John Merrick have won in subsequent decades.

In recent years, Craig Steinberg has won four SCGA Amateur titles (1988, 1991, 1992, 1997), just the third person to accomplish that feat, joining Dawson, who won four times, and Hunter, who won five titles. Scott McGihon joined the list of three-time winners when he won back-to-back titles in 2005-06, in addition to his 2000 win. In 1994, Tiger Woods, the most celebrated golfer of the current generation, won the SCGA Amateur at Hacienda GC, setting a four-round scoring record of 270, helped in large measure by a single-round record 62 in the third round. Woods scoring record held up until 2010 when Scott Travers finished the championship in a record setting 16-under-par. Patrick Cantlay capped off one of the great amateur golf summers by winning the SCGA Amateur in 2011 and Beau Hossler won back-to-back titles in 2013 and 2014.



## 123RD AMATEUR RECAP

Caden Fioroni, UNLV, finished his week at San Diego CC as the only player to card four rounds under par, four rounds under 70, and four rounds that totaled up to 270 (-14). His final round 66 was good enough to set him an astonishing eight strokes clear of the field and to get his name etched on the same trophy as Tiger Woods.


There's no such thing as perfect golf, but Fioroni came as close as one can with a bogey-free 18 holes on Thursday that included three birdies and an eagle on No. 16 that sent the Chula Vista gallery into a frenzy.

Fioroni entered the final round with a two-shot lead that looked plenty in jeopardy after he three-putted for par from 15-feet on No. 2 while both his playing partners, Tyler Kowack and Ian Maspat made birdies. When the final grouping of the 123rd SCGA Amateur made their way to No. 3, Fioroni was clinging to a one-shot lead advantage and looking shaky at best.

But a load of grit lead to pars on Nos. 3 and 4 before Fioroni broke through for a birdie on the fifth to reestab-

lish his two-shot lead. By the time the Rebel added another one at No. 8 he was three strokes clear of Maspat and would never let anyone closer.

Fioroni was in complete control his game hitting 9 of 14 fairways and 13 of 18 greens. He kept a clean



card with zero stress until the 15th hole when he left his approach short and duffed a chip that still didn't reach the green. Moments later he would bury a 12-footer with a Texas Wedge that would have made SDCC's Billy Casper proud.

It took Fioroni eight holes to finally one-putt. But on the back-nine he did it three straight times nailing the coffin closed on everyone else's chances of getting back into the championship.

Despite shooting in the 60's his first three rounds, Fioroni managed to save his best for last with a final round 66 that was capped off by a two-putt par to win the title. His trip around SDCC only took 31 putts on some of the fastest greens in Southern California.
