WELCOME LETTER

DEAR COMPETITORS,

On behalf of the members of The Peninsula Golf & Country Club, the Northern California Golf Association, and the Southern California Golf Association, welcome to the 58th California Women's Amateur Championship.

This is a special edition of the great six-day tradition being held July 22-27 in San Mateo at the home club of Helen Lengfeld for the first time. Helen's career in golf as a player, founder of multiple California Women's Golf Associations and of this very event in 1967 has been widely recognized by her induction into the NCGA Hall of Fame and the California Golf Hall of Fame. Additionally, when she reached age 60, Sports Illustrated honored her with a "lifetime" award as "Mrs. Golf," a title never bestowed on anyone else. Her humanitarian and philanthropic contributions to the Veterans of America were unparalleled and her leadership at Peninsula Golf & Country Club enabled it to survive two World Wars and the Great Depression. The Club has honored her by establishing a permanent display of pictures, stories, and memorabilia to tell the remarkable story of her life. The members welcome you to visit this display in the main hallways of their Clubhouse.

Also there, you'll see a display honoring NCGA Hall of Famer George Archer whose 40 professional victories include the 1969 Masters. You can see many of his trophies and read about the foundation established in his name. If you look closely you will learn about a personal secret not revealed until his death.

You'll be playing golf on a special course too. Peninsula's Donald Ross course is one of just three west of the Mississippi and the only one west of the Rockies. A large display in the Clubhouse tells of Ross' life and how he was lured to make the long journey to San Mateo in 1922. It also chronicles the project to restore the course to his original design in 2001-2002. Major US national golf championships have been held at 30 Ross designed courses!

Winners of this State Championship have gone on to worldwide acclaim in Amateur and Professional golf and we expect many of you will do the same. We wish you all good luck and as Helen often said, "Play well, and have fun."

HELEN LENGFELD

It's fitting that this year's California Women's Amateur Championship is being held at Peninsula Golf and Country Club.

Peninsula G&CC, after all, was the home course of CWAC founder Helen Lengfeld.

Born in 1898, Lengfeld's legacy began as a player, winning her first Club Championship in 1918 at Beresford CC (Peninsula Golf & CC.) She sponsored a Ladies Invitational at Beresford CC in 1925, one of the first big events following Donald Ross' complete redesign of the course. Naturally she won, and in 1926 the Bay Area native won the San Francisco Women's Championship. That same year, she helped found the Women's Golf Association of Northern California and in 1927 won their first Championship, held at The Olympic Club.



Fourteen years later, Lengfeld started the California Women's Golf Circuit, which featured stars such as Babe Zaharias and Patty Berg.

The growth of the Circuit tournaments led to the formation of the Pacific Women's Golf Association,

with Lengfeld becoming the first president in 1947.

Renowned as a philanthropist and humanitarian, Lengfeld was also active in sponsoring tournaments like The WeatherVane at Pebble Beach Golf Links, which would eventually lead to the creation of the Ladies Professional Golf Association. In 1949, she'd publish The Golfer Magazine, which later became The National Golfer for 20 years. All proceeds went to the American Women's Volunteer Services (AWVS), the largest women's service organization in the US during World War II and United Veterans Services (UVS)."

Lengfeld went on to found the California Women's Amateur Championships, which consist of the California Junior Girls' State Championship (the first of its kind on the West Coast), the California Women's Amateur Championship and the California Senior Women's Amateur Championship. Former champions of the events include women's golf greats Juli Inkster, Patty Sheehan and Amy Alcott.

Combining her love of golf and dedication to volunteerism, Helen began a lifelong devotion of service to the VA Hospital system just a month after the start



of WWII. She visited every VA Hospital by car in the United States during WWII, setting up 200 local chapters of the AWVS. After the war she helped put golf in over 60 VA Hospitals with her innovative, Golf Swing Clubs, which provided veterans therapy and rehabilitation through golf. She became President of the UVS, a successor organization to the AWVS, in the 1950's, until her death in 1986.

As a result of her endeavors, Lengfeld became a member of the California Golf Hall of Fame in 1982. She'd later be recognized by Golf Digest as one of the five most influential women in golf. She was inducted into the NCGA Hall of Fame in 2016 and on the 50th anniversary of Title Nine, she was inducted into the San Mateo County Sports Hall of Fame..

Lengfeld died at the age of 88 in 1986, having dedicated the majority of her life to golf and spending much of her personal wealth in supporting the game and to veterans.

In 2022, Peninsula G&CC installed a display honoring the legacy of Lengfeld. Club Historian Michael Jamieson notes the exhibit features over 40 photo-

graphs, trophies and memorabilia items of her life, including Lengfeld's 2016 NCGA Hall of Fame induction award and a golf sweater she wore in competition knitted by her mother-in-law almost 100 years ago.

Peninsula G&CC welcomes players to visit the display on the first floor of the Peninsula G&CC Clubhouse. Additionally, Helen has a permanent locker in the Ladies Locker Room, complete with some of her personal items for viewing.

NORTH/SOUTH CHALLENGE

The North / South Challenge is a two-day competition between the NCGA and the SCGA participants, which takes place during stroke play qualifying on Monday and Tuesday. Each day the five lowest scores from each respective association are counted. The results are based on the scores over the course of the first two rounds. The association with the lowest two-day total is awarded the Lampham Trophy.

CHAMPIONSHIP INFORMATION

STARTING TIMES AND PAIRINGS

- » Starting times and pairings will be e-mailed to players and posted online at <u>scga.org</u> and <u>ncga.org</u> one week in advance of the championship.
- » The lead group should plan to be at their assigned tee 10 minutes in advance of their starting time. Subsequent groups are encouraged to arrive once the preceding group has teed off. Players arriving late will be penalized under Rule 5.3a of the Rules of Golf. For example, the 9:00 a.m. starting time is defined as 9:00:00, and players arriving after that time are considered late.

PRACTICE ROUNDS

- » Each player is limited to play in one practice round at their own expense.
- » Practice rounds can be arranged Tuesday through Thursday by contacting the golf shop at 650-638-2239. \$150 with cart included.
- » As an additional option, practice rounds on Saturday,
 July 20 and Sunday, July 21 are complimentary and limited to one per player. These can only be
 booked through the championship portal by clicking here. (Please do not contact the golf shop to
 book for these dates.)
- » Please note, practice rounds are for players only. Players may bring a caddie, but the caddie may not play.

PARKING AND REGISTRATION

- » Limited parking is available at The Peninsula G&CC, carpooling is encouraged if possible.
- » All participants must check in at the registration table near the pro shop on either Sunday, July 21 (12 3 p.m.) or Monday beginning at 6 a.m.

DRIVING RANGE & PRACTICE FACILITY

- » The driving range will be open by 6:30 a.m. on each day of the championship.
- » Players are also asked to limit range use to 30 minutes in order to accomodate the entire field.

LOCKER ROOM

The locker room will be available for players, but access to lockers will not be available.

SPECTATORS

- » Spectators are welcome and encouraged to attend the California Women's Amateur Championship.
- » Spectators will not be permitted in golf carts.
- » If spectators have any questions leading up to the event, please contact the NCGA Rules &



Competitions Department at tournaments@ncga.org.

FOOD SERVICE

- For Players Only Lunch will be hosted each day of the championship. Monday Thursday there will be a buffet lunch located in the Ballroom of the main clubhouse. It will be open from 11:30am to 3:00pm. On Friday and Saturday lunch will be available at the Grab and Go facility in the Beresford Room adjacent to the Ballroom in the main clubhouse. This facility will also be open from 6:30am to 5:30pm with a selection of offerings that may be charged with major credit cards.
- » **For Caddies and Spectators** The Grab and Go facility in the Beresford Room adjacent to the Ballroom in the main clubhouse is for you. This facility will be open from 6:30 a.m. to 5:30 p.m. with a selection of offerings that may be charged with major credit cards.
- » For Tournament Officials and other Volunteers A breakfast buffet will be available in the Donald Ross Room adjacent to the Pro shop Monday to Wednesday from 6:30 a.m. to 10:00 a.m. Lunch will be available Monday Wednesday in the clubhouse Ballroom from 11:30 a.m. to

3:00 p.m. At all other times, please select items from the Grab and Go facility in the Beresford Room adjacent to the Ballroom in the main clubhouse.

MOBILE DEVICE POLICY

- » Players, caddies, and spectators should turn mobile devices off or to silent mode while on the property and limit calls to inside their vehicle.
- » Live scoring will be available throughout the championship at ncga.org & scga.org.

RULES OF PLAY

- » Prior to the event, participants must review the Policies & Procedures.
- » The <u>Rules of Golf</u> as approved by the USGA and The R&A govern play.

AUTOMOTIVE TRANSPORTATION

- » During a round, a player must not ride on any form of motorized transportation except as authorized or later approved by the Committee. Model Local Rule G-6.
- » Players seeking to use a golf cart due to a medical or ADA-related reason must contact the NCGA in advance of the championship.
- » Pull or push carts (including motorized pull or push carts) are allowed.

DRESS CODE

- » Player and caddie attire is required to be consistent with that seen on the LPGA Tour. Sleeveless and collarless shirts are permitted.
- » Golf skirts, skorts and shorts of any length are permitted.
- » Denim, cut-offs and workout clothes are not allowed. Hats must be worn with brims facing forward, and men's shirts should be tucked in. Non-penetrating soft spikes are required.

CANCELLATION POLICY

- » To withdraw for any reason prior to the start of the championship, a player must notify the NCGA Rules & Competitions Department at **tournaments@ncga.org.** or (831) 625-4653.
- » Failure to notify tournament staff will subject the player to suspension from future competitions.

Refund Policy:

- » Cancelation prior to the entry closing date: Full refund less a \$20 administrative fee.
- » Cancelation after the entry closing date and more than 48 hours prior to the start of the competition: 50% of the entry fee.
- » Cancelation within 48 hours of the start of the competition: No refund.

PACE OF PLAY POLICY

MAXIMUM ALLOWABLE TIME:

The Committee at each competition will determine the maximum allowable time each group is permitted to play the round and each hole. This time will be posted on each player's scorecard, and each player and group is expected to maintain a pace that is faster than the maximum allowable time. A hole ends in stroke play when all players have holed out, and in match play, when all players hole out or the result of the hole is decided. See Rule 23.3c for when a hole is completed in four-ball competition.

IN POSITION:

Groups are expected to remain in position throughout the round. Being in position means:

- » Reaching the teeing area of a par-3 before the group ahead has teed off on the next hole.
- » Reaching the teeing area of a par-4 before the group ahead leaves the putting green of that hole.
- » Reaching the teeing area of a par-5 before the group ahead gets to the putting green of that hole.

WARNING, CHECKPOINTS & PENALTIES:

If a group is over its maximum allowable time and out of position, an CGA official may issue the group a warning and provide a checkpoint by when the group must regain its position (e.g., within the next two or three holes). If a group receives a warning, it will be monitored by an CGA official to observe its pace of play.

- » If a group fails to regain its position by an established checkpoint, all players in the group will be informed that the checkpoint was missed and that one or more players in the group will be liable to receive a one-stroke penalty. The CGA official will then provide another checkpoint by when the group must regain its position.
- » If the group fails to regain its position a second time, one or more players in the group will be liable to receive the general penalty (loss of hole in match play or two penalty strokes in stroke play).



If the Committee identifies that a player (or players) in the group is the cause of the group failing to maintain pace of play and determines other players are playing within the requirements of this policy, those meeting the requirements of this policy may be absolved from penalty while others may.

THE CGA TOURNAMENT COMMITTEE RESERVES THE RIGHT TO REVIEW ALL PENALTY SITUATIONS.

LOCAL RULES AND TERMS OF THE COMPETITION

The Rules of Golf as approved by the United States Golf Association and The R&A govern play. These Local Rules and Terms of the Competition are in effect at all CGA championships and qualifying rounds. See applicable championship or qualifying round Notice to Players and Entry Application for modifications or additions to these Local Rules and Terms of the Competition. Complete text of the Rules and Local Rules may be found in the Official Guide to the Rules of Golf, effective January 2023.

Unless otherwise noted, the penalty for breach of a Local Rule is the general penalty.

LOCAL RULES

OUT OF BOUNDS — Defined by the line between the course-side points of white stakes and fence posts at ground level.

PENALTY AREAS — When a penalty area is defined on only one side, it extends to infinity. When a penalty area is connected to the out-of-bounds edge, the penalty area extends to and coincides with out of bounds.

GROUND UNDER REPAIR – Defined by white lines. French drains are ground under repair.

Ground under repair may include areas of unusual damage but only when so declared by an authorized member of the Committee. When immediately adjacent to an immovable obstruction, such an area is part of that obstruction.

RELIEF FROM SEAMS OF CUT TURF (SOD SEAMS) — Model Local Rule F-7 as prescribed in Section 8 of the Committee Procedures is in effect.

AERATION HOLES – Model Local Rule E-4 as prescribed in Section 8 of the Committee Procedures is in effect.

EDGING GROOVES – Model Local Rule F-19 as prescribed in Section 8 of the Committee Procedures is in effect.

WHITE-LINED AREAS TYING INTO ARTIFICIALLY SURFACED ROADS AND PATHS —White-lined areas of ground under repair and the artificially surfaced roads, paths or other identified obstructions that they are connected to are a single abnormal course condition when taking relief under Rule 16.1.

WOOD CHIPS AND MULCH - Are loose impediments.

INTEGRAL OBJECTS – Include artificial walls and pilings when located in penalty areas or in or adjacent to bunkers.

PROHIBITING USE OF CERTAIN TYPES OF SHOES – Model Local Rule G-7 as prescribed in Section 8 of the Committee Procedures is in effect.

LIST OF CONFORMING DRIVER HEADS – Model Local Rule G-1 as prescribed in Section 8 of the Committee Procedures is in effect.

MISSING PLAYER OR MARKER CERTIFICATION – Model Local Rule L-1 as prescribed in Section 8 of the Committee Procedures is in effect.

PRACTICE — Prior to and after a round in stroke play, a player may practice on the designated practice areas. Rule 5.2b covering practice in stroke play is modified in this way: A player may not practice on the competition course before or between rounds. Penalty for breach of Local Rule, see Rule 5.2.

PACE OF PLAY – See separate memorandum to players for pace of play policy.

STOPPING AND RESUMING PLAY – Model Local Rule J-1 as prescribed in Section 8 of the Committee Procedures is in effect.

All practice areas are closed during an immediate suspension for a dangerous situation until the Committee has declared them open. Players who practice on closed practice areas will be asked to stop practicing; failure to stop practicing might result in disqualification.

An immediate suspension will be signaled by one prolonged air horn note. All other types of suspension will be signaled by three consecutive air horn notes. Resumption of play will be signaled by two short air horn notes.

WHEN COMPETITION IS FINAL:

Stroke Play: When the results and/or qualifiers and alternates have been determined. At championships, when the awards have been presented.

Match Play: When the result of a match has been reported to, and verified by, the committee.

CODE OF CONDUCT* – By submitting an entry for any CGA-administered event, the contestant understands that his/her participation is at the sole discretion of the SCGA. A contestant may be removed from an event either before or during the event at the sole discretion of the CGA. Incidents of unbecoming conduct or actions deemed to be detrimental to the image of the CGA or the "Spirit of the Game" are grounds for such removal and suspension from future SCGA-administered events.

These include, but are not limited to, the following:

- Willful damage of the golf course or golf course property
- Club throwing or unnecessary club tossing
- Offensive or unbecoming language
- Public criticism of golf course or verbal abuse of SCGA staff, officials, volunteers, host club staff or other contestants
- Potential endangerment of others
- Conduct deemed unbecoming
- Failure to post scores for handicapping purposes
- Manipulation of scores posted for handicapping purposes

PENALTY FOR BREACH OF CODE OF CONDUCT

First Offense: Warning
Second Offense: Disqualification

*The Committee may disqualify a player for serious misconduct in failing to meet the Code's standards.

2023 RECAP

KATE VILLEGAS CONTINUES STELLAR SUMMER WITH STATE AM CROWN

It's been a stretch nothing short of dominant for Kate Villegas, dating back to her first SCGA trophy in 2022 and culminating in her greatest achievement yet on Saturday at La Cumbre CC.

As she and her dad, who looped the course with her for six days as Villegas grinded through seven rounds, watched Lauren Sung's par putt to keep the championship match alive lip out on the 15th hole, the moment had finally started to sink in for the rising senior at UCLA.

"It means everything," Villegas said of winning the 57th edition of the California Women's Amateur championship. "I honestly can't believe I'm here. It's been a long week but I'm so grateful to come out on top."

Villegas, who displays a remarkably calm and composed demeanor on the course, couldn't contain her excitement as she instructed her mother to "take a million" photos while she posed with the Helen Lengfeld Trophy.

"I think I'm just [proud of] my mentality most of all," said Villegas. "I just really focused on taking everything one shot at a time, one day at a time and one match at a time and not letting myself get too far ahead or think of the outcome."

Ever since she hoisted her first SCGA Women's Match Play trophy in June of last year at Journey at Pechanga, Villegas has been on a tear. She finished runner-up in the 2023 U.S Women's Four-Ball with her college teammate, Tiffany Le. Less than a month later, she successfully defended her Women's Match Play crown at Goose Creek GC. Seventeen days after that, she can now call herself a California state champion, inscribing her name on the same trophy as Amy Alcott, Julie Inkster and Angel Yin.

All said, Villegas has come out on top in 17 of the last 18 matches she's played in SCGA/USGA-sanctioned events.



"My game has really come a long way," said Villegas. "I'm just really confident right now and I feel like I'm pretty tough to beat just because I limit my mistakes and I'm really confident in match play."

But the latest accomplishment at La Cumbre CC was far from effortless. Following two rounds of stroke play on Monday and Tuesday, Villegas emerged as the 11th seed as the 132-player field was cut to the low 32 players for match play.

She defeated Darae Chung, who was in contention at the SCGA Women's Amateur earlier this year, 3 & 2 to advance to the Round of 16. She followed up with a 2 & 1 win over Daniela Burgos before defeating Zoe Campos (her college teammate who set the La Cumbre CC women's course record in the stroke play portion) 2

& 1 in the quarterfinals to set up a semifinal matchup with third-seeded Taylor Riley.

Villegas raced out to a three-hole lead through the first five and rode the wave to a comfortable 5 & 4 win to advance to the 18-hole final match on Saturday against Sung, the University of Michigan product who'd knocked out the stroke play medalist in the Round of 16.

After Sung broke the tie with a birdie on No. 2, Villegas won the next three holes with pars on three, four and five to open a two-hole advantage. Despite another birdie from Sung on No. 8 that got her one back, Villegas reclaimed her two-hole lead with another par before the turn on No. 9.

Villegas stayed consistent with pars, maintaining the cushion for four more holes. Her state title became official with two more pars on Nos. 14 and 15 that wrapped up a 4 & 3 victory.

"I knew [Sung] was a little bit of a longer hitter but I really didn't let that affect me," said Villegas, "I still laid up. I was just really dialed in with my wedges and my numbers because I knew pars and birdies were good."

Villegas hit just about every fairway throughout the round, and resolutely kept her lead from the third hole onwards. Following her victory in the 2022 Women's Match Play championship, she transferred to UCLA from UC-Riverside, and as an Arcadia native, has rapidly emerged as one of Southern California's top amateurs, poised to make a significant impact in her final season as a key player for the Bruins.



"I've gotten a lot stronger. I've gained about 20 yards which is pretty awesome and I think my short game has improved as well. I think those two are the biggest things," said Villegas. "I'm very excited. Definitely a little confidence booster and I can't wait to start the season."
