(All Skill Levels)

(The Net Division is open to men and women and may include players who won their club's gross / senior gross club championship but do not meet the handicap eligibility requirements listed above)

## THE SCGA TOURNAMENT OF CLUB CHAMPIONS IS SEPARATED INTO FOUR (4) DIVISIONS:

### 1. WOMEN'S CHAMPIONSHIP DIVISION:

- This division is open to women of all skill levels. This division will compete without handicaps

### 2. MEN'S CHAMPIONSHIP DIVISION:

- This division is open to men whose Handicap Index as of the date of registration is 2.4 or below. This division will compete without handicaps.

### 3. SENIOR MEN'S CHAMPIONSHIP DIVISION:

- This division is open to men who are 55 years of age or older as of the date of the championship and whose Handicap Index as of the date of registration is 5.4 or below. This division will compete without handicaps.

### 4. NET DIVISION:

- This division is open to men and women. Flights and course assignments are determined based on the Handicap Indexes of the participants, who will compete using handicaps.



## EACH SCGA MEMBER CLUB MAY SUBMIT UP TO FIVE (5) ENTRY APPLICATIONS AS FOLLOWS:

- One (1) club champion who meets the eligibility requirements may be sent to the Men's Championship Division;
- One (1) club champion who meets the eligibility requirements may be sent to the Women's Championship Division;
- One (1) club champion who meets the eligibility requirements may be sent to the Senior Men's Championship Division;
- Two (2) club champions may be sent to the Net Division.



**PLAYER ELIGIBILITY:** The club champion must be an amateur golfer with a valid Handicap Index who was listed on the club's active GHIN roster at the time he/she won the championship as well as at the time of the championship proper. If your club champion(s) is not available to participate, we regret that no substitution(s) may be made (this includes runner-ups).

**FORMAT:** 18 holes of individual stroke play.

**NET DIVISION HANDICAPS:** Participants in the Net Division will play to 100% of their Course Handicap, which will be determined based on their lowest Handicap Index from Sept. 15 - Dec. 1. In addition, the SCGA Rules and Competitions Committee reserves the right to adjust a player's Course Handicap at any time prior to or during the competition.

**SITE INFORMATION:** Participants will be e-mailed complete championship details shortly following the entry closing date. That information, along with the eventual results, will be available at [scga.org](http://scga.org).

**ENTRY FEE:** \$150. This entry fee includes course usage, range balls, golf cart, and player luncheon. The entry deadline is Sunday, Nov. 24, 2019. Late entries will be accepted and placed on a waiting list to fill spots only if they become available. Participants may either complete the enclosed paper entry or register online at [scga.org](http://scga.org).

**REFUND POLICY:** Requests for refunds prior to the entry deadline will be honored (less a \$10 administrative fee). Requests received after the closing date and 48 hours prior to the event will be honored (less 50% of the entry). No refunds will be honored within 48 hours of the event.
