PLEASE NOTE: WE ARE REQUESTING THAT YOU BRING THIS INFORMATION SHEET TO THE SITE WITH YOU ON THE DAY OF THE EVENT.

CONDITIONS OF THE COMPETITION

1. **QUALIFYING FEE:** There is a mandatory \$50 qualifying fee (\$25 per round) due at the Golf Shop prior to the start of play. All players must show their receipt to their respective starter at the beginning of the morning round.
2. **STARTING TIMES:** Please check in with the starter at your assigned tee at least five to seven minutes in advance of your tee time. The starters will have information to discuss and distribute to each player in the group. Starters will not page players.
3. **TEES:** Play will be from the Blue tee markers. (Hole #8 will play 419 yards as a Par 4, Hole #10 will play 397 yards, Hole #13 will play 462 yards as a par 4). Approx. 6,995
4. **FORMAT:** 18-hole qualifying round. Qualifiers advance to U.S. Amateur Public Links Championship to be held at Cantigny Golf Club in Wheaton, Illinois on July 9-14, 2007. Final number of qualifying spots will be available from the Committee on the day of play.
5. **RULES OF PLAY:**
 - ◆ Play is governed by the USGA Rules of Golf.
 - ◆ Local Rules in effect will be found on the enclosed SCGA Rules Hard Card and the Local Rules Addendum distributed at the site. Disregard all other club posted local rules.
 - ◆ The "**one-ball**" rule will be in effect. During the entire stipulated round the balls a player plays must be of the same brand and type as detailed by a single entry on the current list of Conforming Golf Balls.
 - ◆ Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.), regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the course) are prohibited. Penalty for breach of this condition: DISQUALIFICATION.
 - ◆ **Distance measuring devices are NOT permitted.**
 - ◆ The use of cell phones will NOT be permitted at the club or during the round.
6. **TIES:** In the event of a tie for the last qualifying place or an alternate's position, there will be a sudden-death playoff immediately following the conclusion of regular play.
7. **AUTOMOTIVE TRANSPORTATION:**
Carts will not be permitted for players or caddies. Spectators are not allowed in carts at any time.
8. **PULL CARTS:**
Pull carts are permitted. Club does not rent pull carts.
9. **CADDIES:** Player may bring caddie.
10. **PLAYER CODE OF CONDUCT:**
By submitting an entry for any SCGA-administered competition, the contestant understands that his/her participation is at the sole discretion of the SCGA. A contestant may be removed from any competition at the discretion of the SCGA staff or Rules and Competitions Committee at any time before or during the competition. Incidents of unbecoming conduct or actions deemed to be detrimental to the image of the SCGA or the "Spirit of the Game" are grounds for such removal and suspension from future SCGA-administered competitions. These include, but are not limited to the following:
 - 1) Willful damage of the golf course or golf course property
 - 2) Club throwing or unnecessary club tossing
 - 3) Offensive or unbecoming language

4) Public criticism of golf course or verbal abuse of SCGA staff, officials, volunteers, host club staff or other contestants

5) Potential endangerment of others

6) Conduct deemed unbecoming

11. ATTIRE:
PLAYERS, CADDIES and SPECTATORS must be properly attired in golf shirts, slacks or (bermuda-length dress shorts) and "spikeless" shoes. Jeans (any color or any kind), sweatpants, T-shirts and tank tops will not be permitted during any phase of the competition. Under no circumstances will this attire prohibition be waived for players. Hats are to be worn forward at all times.
ALL CLOTHING MUST BE IN GOOD REPAIR.
12. CANCELLATIONS :
To withdraw for any reason prior to the start of an USGA competition, a player must notify the SCGA Rules and Competitions Department at (818) 432-4169 and the USGA Championship Administration Department at (908) 234-2300.

GENERAL INFORMATION

1. PRACTICE ROUNDS:
Players may make arrangements for practice rounds at their own expense.
Fee: \$37, Monday-Friday; 12 per player for a cart. \$70 (South) on weekends with cart included.
Please call the golf shop up to 7 days in advance to make arrangements.
There is no guarantee that the practice round time and price desired will be available.
2. DRIVING RANGE:
The driving range will be open at 5:45 a.m. You may purchase range balls at the Golf Shop. Fee: \$4, \$6, \$8
3. LOCKER ROOM:
Locker room will not be available. Players are requested to come dressed "ready to play".
4. FOOD SERVICE:
Breakfast and lunch will be available in the restaurant or snack shack from 5:30 until dark. Snack bar will be available on the course from 6:00 until dark.
5. CASH PURCHASES:
* Cash will be accepted for all purchases.
* Reciprocal chits will not be accepted.
* Major credit cards will be accepted. (MC / VISA / AMEX)
