CONDITIONS OF THE COMPETITION

1. **STARTING TIMES:** Please check in with the starter at your assigned tee at least five to seven minutes in advance of your tee time. The starters will have information to discuss and distribute to each player in the group. Starters will not page players.
2. **TEES:** Play will be from the **WHITE** tee markers (approximately 6,395 yards).
Course Rating: 70.8 / Slope: 130
3. **FORMAT:** 18-hole qualifying round. Qualifiers advance to the U.S. Senior Amateur Championship held at Flint Hills National Golf Club in Andover, Kansas on September 1-6, 2007. Final number of qualifying spots will be available from the Committee on the day of play.
4. **RULES OF PLAY:**
 - ◆ Play is governed by the USGA Rules of Golf.
 - ◆ Local Rules in effect will be found on the enclosed USGA Rules Hard Card and the Local Rules Addendum distributed at the site. Disregard all other club posted local rules.
 - ◆ The "**one-ball**" rule will be in effect. During the entire stipulated round the balls a player plays must be of the same brand and type as detailed by a single entry on the current list of Conforming Golf Balls.
 - ◆ **Distance measuring devices are NOT permitted.**
 - ◆ The use of cell phones, pagers, blackberries or any portable phones will NOT be permitted at the club or during the round.
5. **TIES:** In the event of a tie for the last qualifying place or an alternate's position, there will be a sudden-death playoff immediately following the conclusion of regular play.
6. **AUTOMOTIVE TRANSPORTATION:**
Automotive transportation is permissible for players only. Caddies and spectators must walk at all times.
PENALTY: See penalty clause for breach of the condition on transportation prescribed in "Appendix I" of "The Rules of Golf." There will be a maximum of 2 carts per group and 2 bags per cart. Cart rental fee: \$13 per person (players only).
7. **PULL CARTS:** Pull carts are not permitted.
8. **CADDIES:** Player may bring caddie.
9. **PLAYER CODE OF CONDUCT:**
By submitting an entry for any SCGA-administered competition, the contestant understands that his/her participation is at the sole discretion of the SCGA. A contestant may be removed from any competition at the discretion of the SCGA staff or Rules and Competitions Committee at any time before or during the competition. Incidents of unbecoming conduct or actions deemed to be detrimental to the image of the SCGA or the "Spirit of the Game" are grounds for such removal and suspension from future SCGA-administered competitions. These include, but are not limited to the following:
 - 1) Willful damage of the golf course or golf course property
 - 2) Club throwing or unnecessary club tossing
 - 3) Offensive or unbecoming language
 - 4) Public criticism of golf course or verbal abuse of SCGA staff, officials, volunteers, host club staff or other contestants
 - 5) Potential endangerment of others
 - 6) Conduct deemed unbecoming

10. ATTIRE:
PLAYERS, CADDIES and SPECTATORS must be properly attired in collared shirts, slacks or bermuda-length shorts. **Denim, jeans (any color or any kind), cargo shorts, cut-offs, short shorts, sweatpants, T-shirts and tank tops are not permitted.** Players, caddies and spectators will be asked to leave the golf course if they are not properly attired. Under no circumstances will this attire prohibition be waived. Shirrtails must be tucked in and hats must be worn forward and in the proper manner. Hats must be removed in the dining areas of the Clubhouse. Hats must be worn in the proper manner. All clothing must be in good repair.
11. CANCELLATIONS:
To withdraw for any reason prior to the start of an USGA competition, a player must notify the SCGA Rules and Competitions Department at (818) 432-4169 **and** the USGA Championship Administration Department at (908) 234-2300.
